TUITION WAIVERS						
Employee Tuition Waiver: for Permanent F/T up to 6 credits; for Permanent P/T up to 3 credits per semester. This includes immediate family - Spouse and two (2) children.						
Elder Tuition Waiver: 60 years and older; covers 100% of Tuition only.						
1st Time 1st Year Waiver: for students who have graduated from High School or received their HiSet (formerly GED). Good up to One (1) Year from graduation date. Good for 1 Semester Only!!!						
Work Waiver: for students ineligible for PELL due to Financial Aid Reasons.						
Financial Aid Reasons can include: Suspension, Over Income, Over the Credit Cap, and Over the PELL						
Suspension: student failed the previous 2 semesters						
Received the Limit on PELL (LEU): students are eligible for 50% of their PELL (LEU) per semester; when 600% (or 12 semesters) has been reached, they are ineligible to receive any PELL or apply for College Work Study						
Over the Credit Cap: students usually can get up 150% of their credits for a 2 year program. This means that once they reach 60 credits x that by 150% which is 90 credits max and they are no longer eligible for PELL.						
For a 4 year institution the credit cap is 120 x 150% = 180 credits.						
Over Income - Student made too much money in the two (2) previous tax years. (For example: Student applies for FAFSA for the upcoming AY24-25. Their Income will come from their 2022 Income Tax or Wages)						
3rd Party Billing						
3rd Party Billing: Include funding from outside resources such as Montana Voc Rehab, Veterans Admin, etc. Inside resources include BFCC programs. These fundings are a result of a student invoice from BFCC;
